After registration, the candidates will receive an email with his/her registration number and then candidate will forward that e-mail to the Nodal Officer in the University/College at the time of reporting in the UTDs/ affiliated Colleges.

It is again reiterated that it is compulsory/mandatory for each student to submit an online undertaking at www.antiragging.in. Subsequently, an Anti Ragging Undertaking Reference Number is generated by the UGC which is required to be filled by the candidates in the online application form.

MANDATORY CREATION OF IDs OF ACADEMIC BANK OF CREDITS/ AUTOMATED PERMANENT ACADEMIC ACCOUNT REGISTRY (ABC/APAAR ID)

- Academic Bank of Credit (ABC) is a virtual/digital storehouse that contains the information for all the credits earned
 by individual students throughout their learning journey. It will enable students to open their accounts and give
 multiple options for entering and leaving colleges or universities.
- The APAAR/ABC ID acts as a link to download the Grade Card and Degree from the DigiLocker, an online repository where students can securely store essential documents. It is linked to the Academic Bank of Credits (ABC) via the APAAR/ABC ID, and will receive academic credits from institutions through applications, simplifying the verification of academic records etc.
- Every student is required to register for APAAR/ABC ID a unique 12-digit code to store, manage and access all
 their academic credits, including degrees, diplomas, certificates training details and co-curricular accomplishments
 etc.
- The steps for registering them self with the DigiLocker is provided below. Therefore, students are requested to create the ABC ID themselves with the DigiLocker for their future reference. While filling the admission form.


STEPS TO CREATE AN ABC/APAAR ID THROUGH DIGI LOCKER:

- After login into DigiLocker click on Search Documents.
- Navigate to the Academic Bank of Credits section.
- Fill out academic details such as school of University or institute name, course and other information.
- Submit the form to generate the ABC/APAAR ID.
- The ABC/APAAR ID generated can be downloaded and preserved for future use.

Bhiwani city is mentioned in Ain-e-Akbari. It was founded by a Rajput King named Neem Singh after his wife Bhani. The Bhani spelling changed to Bhiyani and subsequently to Bhiwani. Bhiwani has been a prominent centre of commerce since the time of the Mughals. Bhiwani is also known for its temples and is known as the "Small Kashi" of India because of them. Gauri Shankar temple (Kirorimal temple) of Bhiwani is known throughout the country. The district is famous for its mineral resources. Different types of mineral resources such as kankar, saltpeter road metal are available in the district. There are about 110 queries of kankar and building stone in the district. There are about 270 stone crushing units mostly situated in kalyana and Tosham. These stone crushers are meeting the building material demand of the major area.

•Bhiwani is a very advanced city in terms of education. The headquarter of Board of School Education Haryana is situated here. Apart from this and Chaudhary Bansi Lal University, there are about ten technology institutes in Bhiwani, out of which Technological Institute of Textile and Sciences is the only one of its kind in North India. LIBRARY

SPORTS AND PHYSICAL EDUCATION

Bhiwani is a well-known city of Haryana most often termed as mini Cuba in the field of Sports. Bhiwani is a power hub of sports of Haryana as well as India. More than 100 centres for nurturing the youth are being run around the city. The students of University teaching departments and affiliated colleges also participate in different All India Inter-university (AIIU) Championships as well as National and International competitions. During the session 2019-20 the University organized an AIIU Women Wrestling Championship in a successful way. Chaudhary Bansi Lal University is achieving heights of glory in the field of sports. Dattopant Thengadi Centre for Development Studies

Rashtra Rishi Dattopant Bapurao Thengadi(10 November 1920 – 14 October 2004) born in a village Arvi of Wardha district of Maharashtra is known for his unique qualities of institution building, leadership & organizing skills and propounding the Third Way of socio-economic development based on the ideology of Sanatan Dharma. He was greatly influenced by the philosophy of Ekatam Manavvad propounded by Pt. Deen Dayal Upadhyaya. According to him, neither right nor left is the solution to the ills of the world – degradation of the environment, concentration of income & wealth, unemployment and poverty, exploitation of labour, dominance of the western culture and values guided by individualism and self-intersect. The real solution comes only from Indian culture based on the dharma and is the only solution to the problems. Sh. Thengadi Ji was ardent supporter of using labour intensive technologies, decentralization of decision making and use of country made products. He was against western motivated globalization.

He founded and nurtured some of the well-known and today's leading organizations such as **Bharatiya Mazdoor Sangh**(1955), **Bharatiya Kisan Sangh**(1979) and **Swadeshi Jagran Manch**(1991). He authored many books of which most referred are: **The Third Way; Modernization Without Westernization; What Sustains Sangh? Our National Renaissance, It's Directions and Destination; Nationalist Pursuit; The Great Sentinel and The Perspective**. He was a great scholar, philosopher, visionary and orator yet modest, deeply rooted in the past and completely in tune with the modern time and sensitive to the issues of national importance. His ideas and philosophy is much more relevant than ever and thus needs more research and fair implementation.

Rational for the Establishment of Centre

Today world community in general and India in particular are facing several socio-economic crises in many areas. The prominent problems include growing problem of un-employment, rising threat to environment, concentration of wealth into few hands and threat to Indian value system including to the family system. Thengadi Ji's contribution and views on social, economic and political issues, provides an alternative to the philosophies of socialism and capitalism both of which have already failed in the world. It is in this context Chaudhary Bansi Lal University, Bhiwani decided to setup "Dattopant Thengadi Centre for Development Studies" in the faculty of Management and Commerce.

Objectives

The centre shall endeavor to achieve the following objectives:

- To initiate research on issues and ideas brought to public debate by Thengadi Ji.
- To bring his ideas and philosophy into public domain by networking with academic institutions through seminars, workshops and conferences.
- To promote academicians to take research work on issues and ideas propagated by him and publish the findings in research journals, newsletters and newspapers.
- To see how socio-economic policies in India could be evolved on Indian philosophy and value system.
- Special focus shall be on sectors/ topics like employment generation, optimum utilization of local resources, environment protection, modernization without westernization, FDI& WTO related issues, labour welfare, farmers' distress, rural development, poverty elimination, health &education etc.

Re–Energize: Students enjoy attending hobby clubs as they are out of routine enjoyment activities for them. Hobby classes give the students small breaks in their hectic academic life.

Exploring Hidden Talents: Hobby Classes explore the hidden talents. Every person is born with a unique set of skills and abilities. But it is unfortunate that often they are not explored due to the set monotonous regular routines. So when a student joins a hobby class for some activity for which he has a natural inclination, he will not only enjoy but may excel in it professionally too.

Chance for Physical Activity: As most of the hobby clubs involve physical activity, be it any sport, dancing, gardening, fine arts. Along with it, most of the hobbies require mental activity and alertness. These are the very factors that ensure the mental evolvement and development of the students.

Students are given that chance in hobby clubs where they give expression to their creative soul. CURBING THE MENACE OF RAGGING

- Ragging in educational institutions is banned and anyone found guilty of ragging and /or abetting ragging whether actively or passively, or being a part of conspiracy to promote ragging, is liable to be punished in accordance with the UGC Regulations on Curbing the Menace of Ragging in Higher Educational Institutions, 2009 as well as under the panel law for the time being in force.
- 2. The following will be termed as the act of ragging: any disorderly conduct whether by words spoken or written or by any act, which has the effect of teasing, treating or handling with rudeness any other student(s), indulging in rowdy or in-disciplined activities which causes or is likely to cause annoyance, hardship or psychological harm or to raise fear or apprehension thereof in fresher or junior student(s) or asking the student(s) to do any act or perform something, which such student(s) will not do in the ordinary course and which has the effect of causing or generating a sense of shame or embarrassment so as to adversely affect the physique or psyche of a fresher or a junior student.
- 3. Junior students may contact their Chairpersons or other university functionaries like Proctor, Dean Students Welfare or Security Officer for help and guidance.
- 4. University will upload the instructions against ragging on its website along with Anti Ragging Helping Toll Free Number and will also make an Anti-Ragging Committee as per UGC Regulations.
- 5. Candidate is required to submit the undertaking to ensure that they shall not be indulge in ragging (above type of activities)- (Annexure XIX, XX).

RESERVATION OF SEATS IN VARIOUS PROGRAMMES

The seat matrix has been prepared on the basis of the reservation policy notified by the Govt. of Haryana vide Notification No. 22/10/2013 - IGSIII dated 28/2/2013, and instructions received from the State Govt. from time to time on the following basis:

In the event of quota reserved for Physically Handicapped remain unutilized due to non-availability for suitable category of Handicapped Candidates, it may be offered to the Ex-Servicemen and their wards (1%) and the dependents of Freedom Fighters (1%).

Further, 3% reservation is also provided to Ex-serviceman/ Freedom Fighter and their dependents by providing reservation within reservation of 1% of General Category, 1% out of Scheduled Caste and 1% from Backward Classes category for admission to the various educational institutions of the Govt. and Govt. aided / Institutes located in Haryana. As far as Block allocation in Block-A and Block-B of Backward Classes category is concerned, year wise rotational system will be adopted. For example, if Block-A of Backward Classes are given seats in academic year 2018, the next Block i.e. (B) Block of Category of Backward Classes will be given seats in the next academic year 2019 and so on. Further, a roster register for reservation of seats for Ex-Servicemen/Freedom Fighter shall be maintained and carried forward all fractions till one seat is accumulated through different fractions over the years. As and when the total comes to one, a seat will be provided.

GUIDELINES FOR RESERVATION

- 1. The reservation of seats is as per the Reservation Policy of Haryana Govt. and is subject to change/amendment made by the State Govt. from time to time.
- 2. Candidates belonging to SC/DSC/ST are required to submit a certificate from the competent authority as per Annexure-III. The list of Scheduled Castes notified by the Haryana Government is available at Annexure-VIII.
- 3. Candidates belonging to Backward Classes are required to submit a certificate from the competent authority as per Annexure-IV (1 &2). The list of Backward Classes in Haryana notified by the Haryana Government, is available at Annexure-IX. Circular no. 1170-SW (1)-95 dated07.06.95 of the Haryana Govt. for excluding Socially Advanced Persons/Sections (Creamy Layer) from Backward Classes may be referred to at Annexure-XI.
- 4. The children or Grand Children (Maternal & Paternal) of Freedom Fighters are required to submit a certificate from the competent authority as per Annexure-V.
- 5. Only those candidates who have permanent disability of not less than 40% (being otherwise fit for admission to the programme) will be considered for admission as Physically Handicapped. They will submit a certificate from the competent authority as per Annexure-VI. Disability Certificate shall, however, be subject to verification by a Medical Board to be constituted by the University. The decision of Medical Board in this regard shall be final.
- 6. Children or Wards of Military Personnel (including personnel of Para-Military Forces killed in Action or Permanently Disabled in Action and Boarded Out from the Services or Ex-Servicemen and their wards) will be considered for reservation. They will submit a certificate as per Annexure-VI-A. The following categories of personnel of Territorial Army are included in the definition of Ex-Servicemen in terms of the State Govt. letter No. 12/18/2006-GS-II dated 08-01-2008:
 - i) Pension holders for continuous embodied service;
 - ii) Persons with disability attributable to military service;
 - iii) Gallantry Award Winners; and
 - iv) Such recruits boarded out/released on medical grounds and granted medical/disability pension.
- A candidate who applies for a reserved category or for both reserved and general categories will be considered first in general category subject to the preference given for University/programme. In case, he is not selected in general category, he will be considered for reserved category. The Scheduled Castes/Backward Classes candidates who get selected/admitted in Educational/Professional/Technical Institutions and Universities in open competition on the basis of their own merit, will not be counted against the quota reserved for scheduled caste/ backward classes, rather they will be treated as open competition candidates. However, such candidates shall fulfil condition of eligibility regarding age etc. as are meant for general category candidates (Memo No.13864-75 dated 24.08.2012 received from the Principal Secretary to Govt. of Haryana, Welfare of Scheduled Caste and Backward Classes, Department, Chandigarh).
- 8. If a candidate belongs to more than one reserved category, he/she shall be required to give his/her preference at the time of filling up the admission form. Preference once given shall not be changed.
- 9. If any seat remains vacant in sub-categories of BC (A) and BC (B), the same will be filled up through the candidates belonging to other category. For example, if any seat in BC (B) category remains vacant, the same will be filled up from BC (A) category and vice-versa.
- 10. As per the reservation policy of DGHE (Annexure XIII-A) 10% reservation is to be given in both State Quota seats under State Policy and all India Quota seats under Central Government Policy separately.

- V. Reappear candidates will not be allowed admission in B.Ed. (Regular Course) in any case.
- VI. Cut-off date for eligibility will be the last date/time of online choice filling.
- VII. One-year PG diploma in any subject will not be considered equivalent to Master's Degree.

PREPARATION OF MERIT LIST FOR ADMISSION

Merit for admission to B.Ed./M.Ed./PGDRP/ M.A. SWDS Programs shall be determined on the basis of marks obtained in the qualifying examinations. In case of admission in B.Ed. if a candidate has passed the Master's Degree Examination along with Bachelor's Degree, the higher percentage of marks obtained either in Under Graduate or Post Graduate degree will be taken into consideration while preparing the merit list. However, if two or more candidates have obtained equal marks, following procedure will be used for the preparation of merit:

- 1. Candidates with higher percentage of marks obtained in Under-Graduate Program will be taken into consideration.
- 2. Candidate senior in age will be given first preference
- 3. If tie still persists, then marks obtained in 12th will be considered
- 4. If tie still persists, then marks in 10th will be considered to break the tie

In case of M.Ed. merit will be counted on the basis of marks obtained in B.Ed.

DIVISION OF SEATS

50% of the total seats in each college shall be reserved for Group-I i.e. Science & Arts with Math's group candidates. Other 50% seats shall be reserved for Group-II i.e. Arts & Commerce group candidates.

Prerequisites and instructions for filling up of Online Application Form

- 1. An **E-mail ID** for registration and for receiving all future correspondence till the admission process is over and subsequently, if admitted.
- 2. **Mobile Number** to receive **SMS** based notifications/communications related to the online application, admit card, offer of admission/allotment of seat etc. till the admission process is over and subsequently, if admitted.
- 3. All relevant documents i.e., mark sheet of qualifying examination, proof of age and other documents should be uploaded by the candidate along with online application form.
- 4. Incomplete/incorrect application form shall be rejected, summarily.
- 5. The candidates must also upload the conversion formula for conversion of CGPA to percentage, wherever applicable. The candidates are required to fill up the percentage of marks secured in each examination using the formula as before, wherever applicable.
- 6. A recent passport sized **colour photograph** (for scanning and uploading in "jpeg/jpg/png/bmp/gif" format are allowed. File size of scanned photograph should not be more than 100KB).
- 7. Your **signature** using **Blue/Black** pen on white sheet (for scanning and uploading in "jpeg/jpg/png/bmp/gif" format only. File size of scanned photograph should not be more than 100KB).
- 8. Mode of Fee: Net Banking / QR Code / UPI
- 9. Printout of online submitted application form or proof of payment of CBLU admission fee is needed to be submitted to the University. However, the candidates should retain a copy of the said documents for their own record.

GENERAL GUIDELINES FOR CANDIDATES AND AFFILIATED COLLEGES OF EDUCATION

General guidelines for candidates

- 1. Prospectus containing eligibility conditions, list of participating Colleges/Institutions with number of sanctioned seats and reservation policy can be seen/downloaded from University website https://cbluonline.in.
- 2. Before filling the online Application Form, the candidates are required to read the prospectus carefully.
- 3. The Admissions to B.Ed./B.Ed.Spl./M.Ed./M.Ed.Spl./PGDRP /M.A.SWDS Programs run by the affiliated colleges of education of this University for the session 2025-26 will be made on the basis of inter-se-merit of percentage of the qualifying examinations through online counseling by CBL University, Bhiwani.
- 4. In case a candidate has passed the Master Degree Examination also after Bachelor Degree, the higher percentage of marks obtained either in Under Graduate or Post Graduate degree will be taken into consideration while preparing the merit for B.Ed. Program.
- 5. Admission to employed candidate to B.Ed./B.Ed.Spl./M.Ed./M.Ed.Spl./PGDRP /M.A.SWDS Programs (whole time or part time or in honorary capacity) is subject to the submission of No Objection Certificate and leave from the employer for full academic session and must submit the same to the college within one month from the date of admission failing which the admission will be cancelled forfeiting the deposited fee.
- 6. The candidate should ensure his/her eligibility for admission before applying for the program. If, on verification at a later stage, it is found that a candidate does not fulfill the eligibility conditions, his/her candidature will be cancelled and the fee deposited by him/her shall be forfeited.
- 7. On-line registration-cum-counseling fee is Rs. 1000/- (Rs. 500/- registration fee plus Rs.500/- Counseling fee) for General Category and BC candidates and Rs. 625/- (Rs. 125/- registration fee plus Rs. 500/- Counseling fee) for SC/Differently Abled candidates of Haryana state. Registration cum Counseling fee is non-refundable.
- 8. On-line registration-cum-Counseling fee shall be deposited by the candidate through scanning the QR Code only.
- 9. Locking of submitted choices is advisable, however, candidates who do not lock the dries their last filled choice would be considered final.
- 10. Registered candidates who do not fill choices or fail to save the same cannot beconsidered for admission and seat allotment.
- 11. Candidates must take print-out of their online Application Form along with their locked choices. This print-out has to be signed and submitted to the allotted colleges as and when required.

- 12. The outcome of different rounds will be displayed on https://cbluonline.in as per admission schedule. The candidates should download the allotment letter using his/her Registration ID and password allotted at the time of their registration and report to the allotted college through offline mode.
- 13. All the candidates who are allotted seats will have to deposit/submit the prescribed fees in the bank account of the concerned college through online mode in consultation with the college concerned or may visit the college concerned to deposit the fee in cash/through bank challan/online mode
- 14. All the rules and regulations for the submission of migration certificates by the candidates who have passed the qualifying examinations from other universities will be applicable as per the rules of Ch. Bansi Lal University.
- 15. Candidates will have to produce all the relevant certificates in original i.e. Academic Documents (Matric onwards) of all semesters/years, Character Certificate/Certificate from the college last attended, certificate of reservation (if claimed), gap year affidavit (in case of gap in academic qualifications) and Migration Certificate (if any) as and when required by the allotted college.
- 16. For auto-up-gradation purposes, if any, the candidate must have to give in writing and have to submit the same on the e-mail of the allotted college through his/her registered e-mail (mentioned in the application form) alongwith letter of allotment of that college.
- 17. The allotment of seats is liable to be cancelled, if the personal data viz. Category, Subcategory, Group (Group-I Science & Arts with Maths, Group-II Arts & Commerce) residential status (Bonafide Residents of Haryana or All India Category), percentage of marks in qualifying examination, gender etc. submitted by the candidates at the time of registration is found to be wrong at the time of verification of the original certificates at allotted Colleges/Institutes. But, if the candidate is found to be eligible after the correction in personal data, the candidate may be considered forsubsequent rounds of counseling, if any, against the vacancies only.
- 18. If a candidate is admitted on the basis of the information submitted by him/ her, which is found to be incorrect or false at any stage then his/ her admission shall be cancelled and all fees and other dues paid by him/ her shall be forfeited. The University/ College/ Institute may take further action, as deemed fit, against thecandidate in accordance with law.
- 19. Candidate seeking admission in self-financing institutions are advised to ensure that they are lawfully admitted failing which, their admission shall not be authenticated by CBLU, Bhiwani and shall not be registered by the University and they themselves shall be responsible for any such lapse.
- 20. In case, a candidate after having deposited required fee for admission to B.Ed/B.Ed. Special/M.Ed./M.Ed. Special/PGDRP/M.A. SWDS Program 2024-25 decides to leave the Program before the Phase-III of counseling, the fee deposited by the candidate will be refunded to him/her by the concerned college after deducting Rs. 1000/-. After last Counselling the fee shall not be refunded, if the seat remains vacant.

- 21. In case of ambiguity about any rule, the interpretation of the University in the matter will be final.
- 22. All legal disputes relating to admission to B.Ed./B.Ed.Spl./M.Ed./M.Ed.Spl./PGDRP /M.A.SWDS Program will be subject to Courts having jurisdiction at Bhiwani.
- 23. The number of colleges/sanctioned seats may increase or decrease based upon the approval of Apex Body(s) and affiliation from the University.
- 24. Candidates are advised to consult the updated list of colleges on the websites https://cbluonline.in before filling their choice, as intake in various institutes subject to change by the competent authority in view of pending writs/appeals in courts/NCTE with regard to their recognition.
- 25. The attendance rules of the University will be applicable on the admitted students as per ordinance of the B.Ed./B.Ed.Spl./M.Ed.Spl./ PGDRP/M.A. SWDS Program.
- 26. The participating colleges/Institutions will ensure that all the admissions will be made only on the basis of the recognized and valid degree (s)/certificate (s) issued by the approved and recognized boards/Institutes/ Universities. In case any clarification of equivalence/recognition of qualifying degree/certificate/Institute/Board/University if required, the same may be confirmed from the equivalence list available on the University website i.e. www.cblu.ac.in or https://cbluonline.in
- 27. All the updated latest information/notices/changes/modifications will be displayed on the website. The candidates are required to visit the website regularly to obtain the latest information.

GUIDELINES FOR THE CANDIDATES REGARDING ONLINE ADMISSION PROCEDURE

This section provides an overview of the steps involved in counselling and admission process.

A. Online Registration

- I. Candidate should visit website www.cblu.ac.in, https://cbluonline.in
- 2. Candidates should go through prospectus for gathering information/instruction in detail about counselling schedule and procedure which is available on the websites www.cblu.ac.in, https://cbluonline.in
- 3. Candidates will register themselves as per key dates mentioned in the admission schedule for Govt/ Govt Aided/Self-Financing Colleges of Education affiliated to Ch. Bansi Lal University, Bhiwani.
- 4. For participation in online admission process, a candidate has to register by submitting personal data/requisite information correctly in the online application form. On submitting the data/information Registration Id and password will be generated/ created for use in future login by the candidate.
- 5. For subsequent logins, candidates will be able to login directly with their Registration Id and password. Candidates should remember to logout at the end of their session, so that the details filled up by them cannot be tampered with or modified by any unauthorized person.
- 6. Candidates are advised to record/remember their password for future logins and not to disclose or share their password with anybody.
- 7. It is solely the responsibility of the candidates to verify their personal data including Category, Sub category, Group (Science/ Arts with Maths & Art/Commerce), Residential Status, gender etc. are consistent with documentary evidence.
- 8. If the personal data submitted /entered by the candidates are found to be wrong at the time of verification of certificates by the admission committee produced/made available by the candidate through online/offline mode, the provisional allotment of seat is liable to be cancelled.
- 9. Candidates should take a print out (hard copy) of the online application form containing the above personal data for future use.
- Cut off date for eligibility will be the last date/time of online choice filling.

B. Payment of Registration & Counseling Fee.

- Registration and counseling fee of Rs. 1000/- for General & BC Candidates and Rs. 625/for SC/PH candidates of Haryana State be deposited by the candidate through Scanning
 QR code only.
- 2. The Candidates will be able to fill his/ her choices only after depositing the fee. Last date for payment of Registration-cum-counseling fee for Govt/ Govt Aided Colleges of Education and for B.Ed. program under SELF FINANCING SCHEME colleges only is as per key dates mentioned in the admission schedule.

C. Online Choice Filling & Locking

- Online choice filling & locking by the candidate can be done as per key dates mentioned in the admission schedule for Govt./ Govt. Aided/ Self- Financing Colleges of Education in Haryana.
- 2. Candidates are advised to go through the updated list of Colleges of Education affiliated to Ch. Bansi Lal University, Bhiwani on the website www.cblu.ac.in, https://cbluonline.in and should prepare a list of Colleges in order of preference in which they are interested in seeking admission.
- 3. Candidates can fill 10 (ten) choices in order of preference. Candidates are allowed to change or re-order their choices, delete earlier choices and add new choices any number of times until they lock their final choices.
- 4. All the candidates must lock their final choices as per key dates mentioned in the admission schedule.
- 5. Candidates will not be able to unlock their choices once they are locked.
- 6. If a candidate fails to explicitly lock his/her choices by the last date, their last saved choiceswill be automatically locked and allotment will be done on that basis.
- 7. The candidate must take a print out of their locked choices. This print out may be submitted by the candidate, if it is required by the college concerned at any stage.
- 8. Registered candidates who do not fill choices cannot be considered for seat allotment.

D. Online Seat Allotment

I. Seats will be allotted in the order of merit and preference/ choices of the candidate according to admission schedule as mentioned in different rounds.

- The allotment result will be available on the websites https://cbluonline.in Allotment letters will not be sent to the candidates. However, candidates may get a print out of the allotment details from the above websites using their login ID and password.
 - 3. Candidates who are allotted seats will have to report offline to the allotted college and may submit his/her documents required, if any, by the college concerned.

Note:

Eligible candidates for allotment against vacant seats fall into one of the following two groups:

Group-I: Candidates who reported at the allotted college after first round of seat allotment and opted for all the choices of preference higher than the currently allotted seat (auto upgradation) only two time if seats available, the request of the candidate can be considered in the next round.

Group-II: Registered candidates who were not allotted any seats in the first round of seat allotment, auto upgradation will be considered in the subsequent round(s).

E. Online/Offline Reporting at Allotted College/Institute

- 1. The outcome of the different rounds of seat allotment will be displayed on the website https://cbluonline.in (as per admission schedule). Individual allotment letters will not be sent to the candidates by the university.
- 2. All the candidates who get an allotment should take print out of this provisional seat allotment should report online/offline to the allotted college and may submit the documents required, if any by the college concerned as per specified reporting dates for taking admission, failing which their seat allotment shall stand cancelled. Also, they will not be considered for further rounds of seat allotment.
- 3. At the time of reporting, if documents are found correct by the admission committee of the college concerned on verification made available by the candidate through online/offline mode and the fee is paid (as mentioned in the prospectus) by the candidate, then a provisional admission letter generated online will be issued to the candidate by the concerned college. The candidate shall check all the entries in this provisional admission letter and should sign it and preserve it for further reference.

- 4. If a candidate opts for auto upgradation, then a provisional auto up-gradation letter generated online will be issued to the candidate by the concerned college. The candidate shall check all the entries in this provisional auto up-gradation letter and should sign it and preserve it for further reference.
- 5. The allotment of the seat is liable to be cancelled, if the personal data viz. Category, Subcategory, Group (Group-I Science & Arts with Maths Group-II Arts & Commerce) residential status (Bonafide Residents of Haryana or All India Category), percentage of marks in qualifying examination, gender etc. submitted by the candidates at the time of registration is found to be wrong at time of verification by the admission committee ofthe concerned college from the documents made available by the candidate through online/offline mode.
- 6. If the candidate is found to be eligible after the correction in personal data (name, father name, mother name, contact number, email id) can be considered for auto-upgradation in subsequent round of counseling, if any against the vacancies only.
- 7. If a candidate is admitted on the basis of the information submitted by him/ her, which is found to be incorrect or false at any stage then his/ her admission shall be cancelled and all fees and other dues paid by him/ her shall be forfeited. The College/Institute may take further action, as deemed fit, against the candidate in accordance with law.
- 8. The allotment of the seats to candidates who do not report within the stipulated period to the allotted college will be cancelled and these candidates will not be considered in the seats allotment in the subsequent rounds.

LIST OF DOCUMENTS TO BE BROUGHT AT THE TIME OF REPORTING IN THE INSTITUTE:

The candidates, at the time of reporting to the allotted college must bring all the original documents with them and shall submit two sets of photo copies of the required documents, as the case may be:

- (i) Matriculation/ High School Certificate.
- (ii) 10+2/Intermediate/Senior Secondary School Examination Certificate & Detailed Marks Card.
- (iii) Qualifying Examination i.e. Bachelor Degree and /or Master's Degree or Shastri Degree 3-year (with English). The candidate will bring the DMCs of all the years of Bachelor and Master Degree or Shastri.
- (iv) Character Certificate.
 - (a) Regular Candidates: The candidates who have passed their qualifying exam from College/ Department as regular students are required to submit the Character Certificate in original as per Annexure-XXI
 - (b) Private Candidates: Candidates, who have passed the qualifying examination as private candidates should submit their Character Certificate, duly signed by a Notary Public.
 - (c) Gaps in study: Candidates who have gaps in their academic career after the qualifying exam., must furnish a gap certificate, in the form of affidavit on non-judicial stamp paper or certificate from the employer (if in the service) and should also furnish separately the character certificate of gap period duly attested by NotaryPublic.
- (v) Residents Certificate as per **Annexure- II.1 to II.4**, if applicable: Candidates, who have passed their qualifying examination from a university located in the State of Haryana will be deemed to be Haryana resident and will not be required to submit certificates of bonafide residents of Haryana.
- (vi) No Objection Certificate from the Employer in the case of Employees of Govt. of Haryana, members of All India Services borne on Haryana Cadre, Employees of Statutory Bodies/Corporations, if applicable.
- (vii) Scheduled Caste Certificate as per **Annexure-III**, if applicable.
- (viii) Backward Class Certificate as per Annexure-IV. I to IV.2,
- (ix) Economically Weaker Section Certificate as per **Annexure-XIII-B**
- (x) Certificate in respect of Persons with Disabilities Candidates as per **Annexure-VI**, ifapplicable.
- (xi) Certificate required to be furnished by the Children & Grand-Children of Freedom Fighters as per **Annexure-V**, if applicable.
- (xii) Certificate from Ex-Servicemen of Indian Defense Services or Para-Military Forces

- (xiii) Provisional Allotment Letter
- (xiv) Original Receipt of Registration & Counseling Fee.
- (xv) Print out of Online Application form alongwith their locked Choice.

Note:

- (i) If the original certificates are not in Hindi/ English, duly certified Hindi/ Englishversion/ translation of such certificates will be required.
- (ii) The candidates are required to submit 04 (four) latest passport size photographs and 02 sets of attested photo- copies of all applicable documents/testimonials/ certificates to the Principal of the concerned college in person.
- (iii) The original certificates shall be produced by the candidate to the Principal/Admission Committee of the concerned college in person as per counselling schedule.

INSTRUCTIONS FOR COLLEGES

- 1. Every College/Institute shall constitute an Admission Committee to be appointed by the Principal/Chairperson from amongst the teachers of College/Institute.
- 2. Verification of the documents of the candidate will be done by the respective Admission Committee of College/Institute from the documents made available by the candidate through online/offline mode for the admission purposes. At any stage, if the documents found to be false the admission shall automatically have canceled.
- 3. The admission committee may ensure that the candidate has deposited the fee as per his / her entitlement.
- 4. Online reporting of admissions must be done day to day basis by the College/Institute to the University and not on the last date of admissions. No permission of any kind would be provided for admitting students, if status of admission not reported online as per Key dates/schedule.
- 5. After successful admission of the candidate, the institute must issue system generated provisional admission slip/ auto up-gradation letter to candidate, as the case may be.
- 6. Colleges are required to update admission status online on college login provided for the admission purposes strictly as per admission schedule, so that the subsequent counseling may be conducted as per schedule, failing which they will be fined heavily.
- 7. Information about only those candidates, whose admission status has seen reported online, will be forwarded to Registration Branch of University.
- 8. Responsibility for any wrong/irregular/excess admission will entirely rest upon the Principal/Chairperson of the concerned college/institute.
- 9. Admission of candidates who have passed their qualifying examination from other university shall be provisional subject to verification of the eligibility by the Registration Branch of the university.
- 10. All the rules and regulations for submission of Registration Return of students by the college will be applicable as per the rules and schedule of the University.
- 11. Every College must give accurate information on its website regarding human and instructional resources alongwith subjects in which teachers are available in the College.
- 12. The candidate who got admitted provisionally should submit two sets of his/ her documents/ certificates duly self-attested by Candidate in person to the Principal/Admission Committee of the College. The Principal of the college will have to authenticate these documents/ certificates after comparing these from the originals. Under no circumstances the original certificates of the candidate should be retained by the college. One set of the documents/ certificates thus authenticated by the college shall be deposited in the University, for the purpose of registration, for which no original certificate shall be demanded. Anyhow, if theaffiliating University, so desires the original certificates from the candidate can be demanded through the institute of his/ her admission for any purpose what so ever these may be.

ENROLMENT OF STUDENTS, SUBMISSION OF REGISTRATION RETURN, MIGRATION AND OTHER FEES DETAILS FOR UTDs, SJUC AND AFFILIATED COLLEGES (DEGREE/PROFESSIONAL/EDUCATION PROGRAMMES ETC.)

I. The Principals of affiliated/ maintained colleges/ institutes will complete the process of online submission of Registration Return and Continuation Return (particulars in the RR/CR should be as per documents of the students) within 30 days from the last date of admission (without late fee) of a course and a "Hard Copy" of the same will be submitted along with all types of required certificates/documents (photocopies duly attested) exhibiting their eligibility and migration certificate in the R & S Branch within 7 days after completing all formalities i.e. depositing of required fee relating to different type of fees applicable for a respective session.

If a College/Institute fails to submit the documents/certificate along with the hard copy of the RR, the late fee as under will be charged as per prescribed schedule: -

I am directed to invite your attention to Government instructions No. 62/17/95-6GS-I, dated 03.10.1996 and No. 62/03/2021-6GS-I, dated 14.01.2021 on the subject cited above and to say that Government has decided to further revise para 1(v) of the instructions as under:-

1(v) (A) For the purpose of Employment of Haryana Residents under the Haryana State Employment of Local Candidates. Act 2020 and for the purpose of Grant of Employment Generation Subsidy to industrial units under the Haryana Employment and Entrepreneurship Policy, 2020 or other sector specific industrial policies - Children/dependents/wards (if parents are not living) of persons who have permanent home in Haryana since a period not less than Five (5) years; or who have permanent home in Haryana since a period not less than Five (5) years but on account of their occupation they are living outside Haryana; or who do not have permanent residence in Haryana but have been residing in Haryana for a period not less than Five (5) years.

(B) For the purpose of admissions, scholarships, unemployment allowance and weightage under Socio-economic Criteria - Children/dependents/wards (if parents are not living) of persons who have permanent home in Haryana since a period not less than Fifteen (15) years, or who have permanent home in Haryana since a period not less than Fifteen (15) years but on account of their occupation they are living outside Haryana, or who do not have permanent residence in Haryana but have been residing in Haryana for a period not less than Fifteen (15) years.

 These instructions will be applicable with immediate effect and may please be brought to the notice of all concerned

Instructions regarding Bonafide Residents of Haryana issued vide letter No.62/17/95-6 GSI dated 3rd October, 1996, No.62/32/2000-6GSI dated 23rd May, 2003, No.62/27/2003-6GSI dated 29th July, 2003 and No.62/62/2011-6GSI dated 17th January, 2012 by the Chief Secretary to Government, Haryana.

Subject: Bonafide residents of Haryana - Guidelines regarding.

- I. I am directed to invite your attention to Haryana Govt. letters noted in the margin on the subject noted above vide which the instructions were issued regarding simplification of procedure for obtaining the certificate of Domicile for the purpose of admission to educational institution (including technical/ medical institution). The matter has been reconsidered in the light of judgment delivered by the Hon'ble Supreme Court of India in the case of Dr Pradeep Jain vs. Union of India and others reported as AIR 1984-SC-1421, wherein it has been held that instead of the word 'Domicile' the word 'Resident' be used in the instructions issued by the State Government and it has been decided to revise the Government instructions. Henceforth, the following categories of persons would be eligible for the grant of Resident Certificate: -
- (i) Candidates, who have passed the examination qualifying there for selection in an institution from a school/college in Haryana.
- (ii) Children/Wards (if parents are not living)/Dependents: -
- (a) of the regular employees of Haryana State posted in or outside Haryana State or working on deputation;
- **(b)** of the regular employees of the statutory bodies/corporations established by or under an act of the State of Haryana who are posted in Chandigarh or in Haryana or outside Haryana.
- (c) of the regular employees of the Government of India posted in Chandigarh or in Haryana in connection with the affairs of the Haryana Government;
- (iii) Children/wards (if parents not living)/dependents of persons who after retirement have permanently settled in Haryana and draw their pensions from the treasuries situated in the State of Haryana.
- (iv) Children/wards (if parents are not living)/dependents of pensioners of Haryana Government irrespective of the fact that the original home of the retiree is in a state other than Haryana or he has settled after retirement in or outside Haryana;
- (v) Children/Wards (if parents are not living)/dependents of persons, who have permanent home in Haryana and include persons who have been residing in Haryana for a period of not less than 15 years or who have permanent home in Haryana but on account of their occupation they are living outside Haryana;
- (vi) The wives of such persons who are bonafide residents of Haryana irrespective of the fact that they had belonged to any other State before marriage;
- (vii) Persons who were born in Haryana and produce a certificate to that effect; provided that the parents/guardians (if parents are not living) of persons belonging to any one of the above-mentioned categories are:
- (a) Citizen of India:
- (b) Produce an affidavit to the effect that they or their children/wards (if parents are not living)/ dependents have not obtained the benefit of Resident in any other State.
- (viii) Children & Wards of the accredited journalists residing at Chandigarh and recognized by Govt. of Haryana.
- 2. All candidates claiming to be bonafide residents of Haryana should produce a Haryana Resident Certificate signed by the District Magistrate/General Assistant to Deputy Commissioner or Sub- Divisional Officer (Civil) of the District/Sub-Divisions/Tehsildars of Revenue to which the candidates belong. Resident Certificates in respect of elsewhere or in respect of the Children/Wards/Dependents of Haryana Govt. employees who are posted at Chandigarh, Delhi or elsewhere or in respect of Children/Wards/Dependents of pensioners of Haryana Govt. or in respect of the Children/Wards/Department of the employees of the Government of India posted at Chandigarh or in Haryana in connection with the affairs of Haryana Government, or in respect of Children/Wards/Dependents of the employees and retirees of the Statutory Bodies/Corporations of Haryana established by or under an Act of the State of Haryana or a Central Act and located at Chandigarh, Haryana or outside Haryana, should be by their respective Heads of Departments.
- 3. Candidates seeking admission in educational institutions (including medical and technical institutions) located in Haryana, may not be required to produce Resident Certificate, if they have passed the examination from a school/college situated in Haryana. For this purpose, a certificate of the Principal/ Headmaster from concerned institution where the children/wards studied last should be considered sufficient. The Principal/ Headmaster of the institution shall be competent to issue such certificate, which should be sufficient.
- 4. If a candidate is admitted on the basis of claim that he belongs to the State of Haryana but at any subsequent time is discovered that his claim was false, the student shall be removed from the institution, all fees and other dues paid up to the date of such removal shall be confiscated. The Principal/Headmaster may take such other action against the student and his/her parents/guardians as he may deem proper in the circumstances of any particular case.
- 5. The children/wards/dependents of the employees of Punjab & Haryana High Court, who are discharging their duties in connection with the affairs of the State of Haryana and have not availed facility from their parent State, the State of Punjab and U.T. Administration Chandigarh, would also be eligible for grant of Resident Certificate of the State of Haryana only for the purpose of admission in academic/technical/ medical institutions of the State of Haryana. However, in that case the employees of the Punjab & Haryana High Court shall be entitled to draw this benefit at one place/State only. Head of the Department of the Punjab & Haryana High Court would be competent to issue such a certificate.





No. Leg.15/2020.—The following Act of the Legislature of the State of Haryana received the assent of the Governor of Haryana on the 25th March, 2020 and is hereby published for general information:-

HARYANA ACT NO. 14 OF 2020

THE HARYANA SCHEDULED CASTES (RESERVATION IN ADMISSION IN GOVERNMENT EDUCATIONAL INSTITUTIONS) ACT, 2020

AN

ACT

to provide for reservation in admission in Government educational institutions to persons belonging to the Scheduled Castes in the State of Haryana with special measures for deprived Scheduled Castes and for matters connected therewith or incidental thereto.

Be it enacted by the Legislature of the State of Haryana in the Seventy-first Year of the Republic of India as follows:-

- This Act may be called the Haryana Scheduled Castes (Reservation in Admission in Short title. Government Educational Institutions) Act, 2020.
- 2. In this Act, unless the context otherwise requires,-

Definitions.

- (a) "Annexure" means the Annexure appended to this Act;
- (b) "competent authority" means an officer appointed under section 5;
- (c) "deprived Scheduled Castes" means such Scheduled Castes as specified in Annexure:
- (d) "Government educational institution" means any higher education institution established and maintained by the Government or receiving aid out of the State funds, imparting education leading to the award of a degree including a post-graduate degree and shall include Government aided technical and professional institutions;
- (e) "Government" means the Government of the State of Haryana in the administrative department;
- (f) "prescribed" means prescribed by the rules;
- (g) "Scheduled Castes" means Scheduled Castes notified under article 341 of the Constitution of India.
- Twenty per cent seats shall be reserved for the members of the Scheduled Castes Re while making admission in Government educational institutions.

Reservation.

- (2) Fifty per cent of the twenty per cent seats reserved for Scheduled Castes for admission in any Government educational institution shall be set aside for candidates belonging to deprived Scheduled Castes as enumerated in the Annexure.
- 4. Where a seat set aside for candidate from deprived Scheduled Castes for admission in Government educational institutions is not filled up in any academic year due to non-availability of candidate of deprived Scheduled Castes possessing the requisite qualifications, the same shall be made available to candidate of Scheduled Castes.

Seats not to be carried forward to next year.

Competent authority to issue certificate.

- (1) The Government may, by notification, appoint any officer as competent authority for the purposes of carrying out the provisions of this Act.
 - (2) The competent authority shall, for the purposes of section 3, issue caste identification certificate specifying the caste name of the Scheduled Caste, in such manner, as may be prescribed.
 - (3) The competent authority shall, for the purposes of this Act, exercise such powers and perform such functions, as may be prescribed.
 - (4) The competent authority shall be deemed to be a public servant within the meaning of section 21 of the Indian Penal Code, 1860 (Central Act 45 of 1860).

Certificate of identification.

6. A person belonging to the deprived Scheduled Castes shall, for the purposes of section 3, support his candidature by a certificate of caste identification issued by the competent authority under sub-section (2) of section 5.

Protection of action taken in good faith.

7. No suit, prosecution or other legal proceedings shall lie against the competent authority, officers of the Government for anything which is in good faith done or intended to be done under this Act or any rule or order made thereunder.

Power to remove difficulties.

8. If any difficulty arises in giving effect to the provisions of this Act, the Government may, by order, published in the Official Gazette, make such provisions not inconsistent with the provisions of this Act, as may appear to be necessary for removing the difficulty:

Provided that no such order shall be made under this section after the expiry of three years from the commencement of this Act.

Power to make rules.

- (1) The Government shall, by notification in the Official Gazette, make rules for carrying out the purposes of this Act.
 - (2) Every rule made under this Act shall, as soon as possible, after it is made, be laid before the State Legislature.

Review of Annexure

10. The Government may, on the basis of such criteria, as may be prescribed and on the expiration of ten years from the coming into force of this Act and at every succeeding period of five years thereafter, review the Scheduled Castes included in the Annexure.

- Section 3. (1) Twenty per cent seats shall be reserved for the members of the Scheduled Castes while making admission in Government educational institutions.
- Fifty per cent of the twenty percent seats reserved for Scheduled Castes for admission in any government educational institution shall be set aside for candidates belonging to the Deprived Scheduled Caste as enumerated in the Annexure.
- A person belonging to the Deprived Scheduled Castes shall, Section 6. for the purposes of section 3, support his candidature by a certificate of caste indentification issued by the ecompetent authority under sub-section (2) of section 5.
- In this Act, 36 Castes were included in the list of Deprived Scheduled Castes 2. at Annexure to this Act. For proper implementation of this Act, all the authorites competent to issue Caste Certificate are directed to mention clearly that the Certificate is of 'Deprived Scheduled Caste' or 'Scheduled Caste' so that at the time of admission the Institutions may find out easily as to how many candidates applied

for admission and how many have been given admission under 'Deprived Scheduled Caste' category.

Sub: Exclusion of socially advanced persons/sections (Creamy Layer) from Backward Classes.

Sir,

I am directed to invite your attention to the subject mentioned above and to state that following the Supreme Court judgement in the Indira Sawhney and others versus Union of India case, the Haryana Government vide notification dated 12.10.1993 had set up the Haryana Second Backward Classes Commission. The terms of reference of this Commission were to entertain, examine and recommend upon requests for inclusion and complaints of overinclusion and under-inclusion in the list of Backward Classes. Vide notification dated 26-5-1994, the Commission was also assigned the function of specifying the basis, applying the relevant and requisite socio-economic criteria to exclude socially advanced persons/sections (Creamy Layer) from Backward Classes.

In its report submitted on 16.5.1995, the Haryana Second Backward Classes Commission had recommended the criteria for excluding socially advanced persons/sections (Creamy Layer) from Backward Classes. After considering these recommendations, the Government has decided that the benefit of reservation shall not apply to persons/ sections mentioned in Annexure 'A', which is enclosed.

All the departments are requested to bring the above instructions to the notice of all the Heads of Departments and appointing authorities under their control for necessary compliance.

Description of Category To whom rule of exclusion will apply

- I. Constitutional Posts Son(s) and daughter(s) of
- a) President of India:
- b) Vice President of India:
- c) Judges of the Supreme Court and of the High Courts;
- d) Chairman and Members of UPSC and of the State Public Service Commission; Chief Election Commissioner; Controller and Auditor General of India;
- e) Persons holding Constitutional positions of like nature.

II. Son(s) and daughter(s) of

- a) parents, both of whom are Class-I Officers;
- b) parents, either of whom is a Class-I Officer;
- c) parents, both of whom are Class-I Officers, but one of them dies or suffers permanent incapacitation.
- d) parents, either of whom is a Class-I Officer and such parent dies or suffers permanent incapacitation and before such death or such* incapacitation has had the benefit of employment in any International Organization like UN, IMF, World Bank, etc. for a period of not less than 5 years.
- e) parents, both of whom are Class-I Officers die or suffer permanent incapacitation and before such death or such incapacitation of the both, either of them has the benefit of employment in any Inter-National Organization like UN, IMF, World Bank, etc. for a period of not less than 5 years.
- A. Provided that the rule of exclusion shall not apply in the following cases:
- a) Sons and daughters of parents either of whom or both of whom are Class-I Officers and such parent(s) dies/die or suffer permanent incapacitation.
- b) A lady belonging to OBC category has got married to a Class-I Officer and may herself like to apply for a job.
- B. Son(s) and daughter(s) of
- a) parents both of whom are Class-II Officers.
- b) parents of whom only the husband is a Class-I Officer and he gets into Class-I at the age of 40 or earlier.
- c) parents, both of whom are Class- II officers and one of them dies or suffers permanent incapacitation and either one of them has had the benefit of employment in any Inter-National Organization like UN, IMF, World Bank, etc. for a period of not less than 5 years before such death or permanent incapacitation;
- d) parents of whom the husband is a Class- I Officer (direct recruit or pre-forty promoted) and the wife is a Class- II officer and the wife dies or suffers permanent incapacitation; and
- e) parents, of whom the wife is a Class I officer (Direct Recruit or pre-forty promoted) and the husband is a Class-II officer & the husband dies or suffers permanent incapacitation. Provided that the rule of exclusion shall not apply in the following cases:
 - Sons and daughters of
- a) parents, both of whom are Class II officers and one of them dies or suffers permanent incapacitation.

- b) parents, both of whom are Class-II officers and both of them die or suffer permanent incapacitation, even though either of them has had the benefit of employment in any Inter-national Organisation like UN, IMF, World Bank, etc. for a period of not less than 5 years before their death or permanent incapacitation.
- C. The criteria enumerated in A & B above in this Category will apply mutatis mutandi to officers holding equivalent or comparable posts in PSUs, Banks, Insurance Organizations, Universities, etc. pending the evaluation of the posts on equivalent or comparable basis in these institutions, the criteria specified in Category V below will apply to the officers in these Institutions.
- III Sons(s) and daughter(s) of parents either or both of whom is or are in the rank of Colonel and above in the army and to equivalent posts in the Navy and the Air Force and the Para Military Forces:

Provided that -

- i) If the wife of an Armed Forces Officer is herself in the Armed Forces (i.e. the category under consideration), the rule of exclusion will apply only when she herself has reached the rank of Colonel;
- ii) the service ranks below Colonel of husband and wife shall not be clubbed together;
- iii) If the wife of an officer in the Armed Forces is in Civil employment, this will not be taken into account for applying the rule of exclusion unless she falls in the service category under item No. II in which case the criteria and conditions enumerated therein will apply to her independently.
- IV Son(s) and daughter(s) of persons belonging to a family (father, mother and minor children) which owns land more than land permissible under the Ceiling Act of Haryana State.
- V Income/Wealth Tax Son(s) and daughter(s) of:
- a) Persons having gross annual income of Rs. 4.50 lakhs or above or possessing wealth above the exemption limit as prescribed in the Wealth Tax Act for a period of three consecutive years. (Range of income has been revised from Rs. 2.50 lakhs to Rs. 4.50 lakhs vide Chief Secretary Letter No. 22/22/2004-3GS-III dated 22.01.2009).
- b) Persons in Categories I, II, III & IV who are not disentitled to the benefit of reservation but have income from other sources of wealth which will bring them within the income/wealth criteria mentioned in (a) above.

Explanation:

- i) Income from salaries or agricultural land shall not be clubbed;
- ii) The income criteria in terms of rupee will be modified taking into account the change in its value every three years. If the situation, however, so demands, the interregnum may be less.
- iii) Where the husband is in some profession and the wife is in a Class II or lower grade employment, the income/wealth test will apply only on the basis of the husband's income.
- iv) If the wife is in any profession and the husband is in employment in a Class II or lower rank post, then the income/wealth criterion will apply only on the basis of the wife's income and the husband's income will not be clubbed with it.

Explanation: Wherever the expression, 'permanent incapacitation' occurs in this schedule it shall mean incapacitation which results in putting an Officer out of service.

Sir,

I am directed to invite your attention to the Govt. of Haryana, Social Welfare Department letter No. 1170-SW (1) 95, dated 7.6.95 on the subject noted above, therein criteria was laid down to assess the creamy layer persons of Haryana Backward Classes in Haryana State. The Backward Classes of Haryana are facing difficulty in obtaining the Backward Classes certificate from the certificate issuing authority due to some understanding in the instructions dated 7.6.95. After careful consideration the Govt. of Haryana has decided to issue clear cut directions to all the Heads of Departments and Deputy Commissioners in the state for issuing Backward Classes Certificate without any further delay.

It is clarified that the income from salary will not be taken into account for the purpose of income/wealth tax in respect of service category and while calculating income or wealth tax of the Government employee of Backward Classes who is not covered under Annexure-A, description of categories No. I, II (a,b,c,d) and III & IV, hence becoming entitled for the benefit of reservation under Backward Classes category, his salary should not be included but his other sources of income/wealth be included for income/wealth tax. All the departments are requested to bring the above instructions to the notice of all the Head of Departments and appointing authorities under their control for necessary compliance.

The left out quota shall go to that class of Backward Classes of citizens who carn more than Three Lakh rupees but upto Six Lakh rupees per annum. The sections of the Backward Classes earning above Six Lakh rupees per annum shall be considered as Creamy Layer under section 5 of the said Act.

No. Leg.18/2016.— The following Act of the Legislature of the State of Haryana received the assent of the Governor of Haryana on the 1st April, 2016 and is hereby published for general information:-

HARYANA ACT NO. 15 OF 2016.

THE HARYANA BACKWARD CLASSES (RESERVATION IN SERVICES AND ADMISSION IN EDUCATIONAL INSTITUTIONS) ACT, 2016.

AN

ACT

To provide for reservation in services and admission in educational institutions to persons belonging to Backward Classes in the State of Haryana and for matters connected therewith or incidental thereto.

WHEREAS clause (4) of article 15 of the Constitution of India enables the State to make special provision for the advancement of any socially and educationally Backward Classes of citizens or for the Scheduled Castes and Scheduled Tribes;

AND WHEREAS clause (5) of article 15 of the Constitution of India enables the State to make special provisions, by law, for the advancement of any socially and educationally Backward Classes of citizens or for the Scheduled Castes or Scheduled Tribes in so far as such special provisions relate to their admission to educational institutions including private aided educational institutions whether aided or unaided by the State, other than minority educational institutions referred to in clause (1) of article 30 of the Constitution;

AND WHEREAS clause (4) of article 16 of the Constitution enables the State to make any provision for the reservation of appointments or posts in favour of any Backward Classes of citizens which, in the opinion of the State, is not adequately represented in the services under the State:

AND WHEREAS clause (1) of article 38 of the Constitution provides that State shall strive to promote the welfare of the people by securing and protecting as effectively as it may a social order in which justice, social, economic and political, shall inform all the institutions of the national life:

AND WHEREAS clause (2) of article 38 of the Constitution provides that the State shall in particular strive to minimize the inequality in income, and endeavour to eliminate inequalities in status, facilities and opportunities, not only amongst individuals but also amongst groups of people residing in different areas or engaged in different vocations;

AND WHEREAS under article 46 of the Constitution, the State shall promote with special care, the educational and economic interest of the weaker sections of the people, and, in particular, of the Scheduled Castes and Scheduled Tribes, and shall protect them from social injustice and all forms of exploitations;

AND WHEREAS the State of Haryana has decided to provide for reservation of seats in educational institutions including private educational institutions aided by the State;

AND WHEREAS the State of Haryana is of the opinion that the Backward Classes of citizens in the State are not adequately represented in the services under the State and therefore, it has been decided to provide for reservation of seats in appointments in the services under the State to Backward Classes.

Be it enacted by the Legislature of the State of Haryana in the Sixty-seventh Year of the Republic of India as follows:-

Short title.

Definitions.

- 1. This Act may be called the Haryana Backward Classes (Reservation in Services and Admissions in Educational Institutions) Act, 2016.
- 2. In this Act, unless the context otherwise requires,-
 - (a) "appointment" means an appointment by direct recruitment;
 - (b) "Backward Classes" means such classes of citizens as specified in Schedule I, II or III;
 - (c) "competent authority" means an officer or an authority authorised to make admission into educational institutions or appointment in services under the State or an authority empowered by the State under sections 8 and 9, as the case may be;
 - (d) "creamy layer" means such class of persons within the Backward Classes as the State Government may, by notification in the Official Gazette specify for the purposes of this Act;
 - (e) "educational institutions" means any institution imparting education, established and maintained by the Government, or receiving aid out of the State funds, and includes Government/Government Aided Technical and Professional Institutions;
 - (f) "Government" means the Government of the State of Haryana;
 - (g) "prescribed" means prescribed by the rules made under this Act;
 - (h) "Schedule" means the Schedules appended to this Act; and
 - (i) "services" means and includes the services under the Government, the Legislature of the State, any institution of Self Government, any local authority, any corporation or company owned or controlled by the State or any such other authority.

Reservation in services. 3. While making appointment, reservation shall be made for the members of the Backward Classes as specified in the Schedule.

Reservation in educational institutions.

4. While making admissions in educational institutions, reservation shall be made for the members of the Backward Classes as specified in the Schedule.

Restrictions with regards to creamy layer.

- 5. (1) Notwithstanding anything contained in this Act, no person belonging to the creamy layer of Backward Classes shall be—
 - (a) considered for admission in educational institutions against the seats reserved therein for Backward Classes as specified in the Schedule; or
 - (b) entitled to claim reservation in or be considered for appointment in services under the State against the posts reserved for Backward Classes as specified in the Schedule.
- (2) The Government shall, by notification, after taking into consideration social, economic and such other factors, as deemed appropriate, specify the criteria for exclusion and identification of persons belonging to the Backward Classes as creamy layer.
 - (3) The criteria fixed under sub-section (2) shall be reviewed every three years.

Horizontal reservation.

6. Notwithstanding anything contained in this Act, the State Government may provide for horizontal reservation for such category or categories of persons within Backward Classes, as it may deem necessary from time to time.

Seats for admission not to be carried forward to next year. 7. Where the seats reserved for Backward Classes for admission in educational institutions are not filled up in any academic year due to non-availability of candidates possessing the requisite qualifications, the same shall, after the display of the final list of such admissions for that year, be made available to candidates of general categories by the educational institution.

Competent authority to issue certificate.

- **8.** (1) The Government may, by notification, appoint any officer to be the competent authority for the purposes of carrying out the provisions of this Act.
- (2) The competent authority may, for the purposes of sections 3 and 4, issue caste identification certificate in terms of Schedule in such manner, as may be prescribed.
- (3) The competent authority shall exercise such powers and perform such functions, as may be prescribed.
- (4) The competent authority shall be deemed to be a public servant within the meaning of section 21 of the Indian Penal Code, 1860 (45 of 1860).

- 9. A person belonging to the Backward Class as specified in the Schedule shall, for the purposes of sections 3 and 4, support his candidature by a certificate of caste identification issued by the competent authority.
- 10. No suit, prosecution or other legal proceeding shall lie against the competent authority, officers of the Government for anything which is in good faith done or intended to be done under this Act, or any rule or order made thereunder.
- 11. If any difficulty arises in giving effect to the provisions of this Act, the State Government may, by order, published in the Official Gazette, make such provisions not inconsistent with the provisions of this Act as may appear to be necessary for removing the difficulty:

Provided that no such order shall be made under this section after the expiry of three years from the commencement of this Act.

- 12. (1) The Government shall, by notification in the Official Gazette, make rules for carrying out the purposes of this Act.
- (2) Every rule made under this Act shall, as soon as possible, after it is made or issued, be laid before the State Legislature.
- 13. The Government shall at the expiration of ten years from the coming into force of this Act and at every succeeding period of ten years thereafter, undertake revision of the Schedule.
- 14. The provisions of this Act shall have effect, notwithstanding anything inconsistent therewith contained in any other State law for the time being in force or any instrument having effect by virtue of any such law.
- 15. Notwithstanding anything contained in any judgment, decree or order of any court or other authority, the reservation made, and anything done or any action taken on the basis of such reservation, by the Government for admission to educational institutions and for appointment in the services for the Backward Classes on the date of coming into force of this Act, shall, for all purposes be deemed to be and to have always been, validly made, done or taken in accordance with law, as if this Act had been in force at all material times when such reservation has been made and such thing done or action taken.
